INDEPENDENT AUDITOR'S REPORT

To the Members of Best Exim Private Limited

Report on the Financial Statements

We have audited the accompanying financial statements of Best Exim Private Limited ("the Company"), which comprise the Balance Sheet as at 31st March, 2016, the Statement of Profit and Loss and the Cash Flow Statement for the year then ended, and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

NOTE NO. 2 SIGNIFICANT ACCOUNTING POLICIES

(a) Basis of preparation

Provisions are not discounted to its present value and are determined based on best estimate required to settle the obligation at the balance sheet date. These are reviewed at each balance sheet date and adjusted to reflect the current best estimates.

(d) Revenue Recognition

Expenses and Income are accounted for on Accrual basis.

e) Taxation

- i) Provision for Current Tax is made after taking into consideration prevailing provisions of the Income Tax Act,1961.
- ii) Deferred Tax is measured based on the Tax rates and the Tax Laws enacted or substantially enacted at the Balance Sheet date, however deferred tax asset is not recognized in the books of accounts.

(f) Contingent Liabilities

Contingent Liabilities are not provided and are disclosed in Notes on Accounts. A disclosure for a contingent liability is made when there is a possible obligation or a present obligation that may, but probably will not, require an outflow of resources. When there is a possible obligation or a present obligation in respect of which the likelihood of outflow of resources is remote, no provision or disclosure is made.
