THE US SENATE narrowly approved a tax overhaul on Saturday, moving Republicans and President Donald Trump a big step closer to their goal of slashing taxes for businesses and the rich while offering everyday Americans a mixed bag of changes. In what would be the largest change to US tax laws since the 1980s, Republicans want to add \$1.4 trillion over 10 years to the \$20 trillion national

SPECIAL COUNSEL ROBERT Mueller plowed into the centre of Trump's administration, securing a guilty plea from Trump's first NSA and placing markers on two

other advisers, including the Trump's son-in-law, Jared Kushner. Michael Flynn admitted he lied to FBI agents in January about conversations he'd had with Russia's ambassador to the US. But he testified on Friday that he had fully informed members

of Trump's transition team about the communications, and had been guided by them. In court, Flynn explained what really happened. In late December, a "very senior member" of his transition team urged Flynn to seek Russia's support on a UN security matter.
